Resolution Requesting Approval of Items of Revenue and Appropriation

WHEREAS, NJS 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

WHEREAS, the Director may also approve the insertion of an appropriation for the equal amount;

WHEREAS, the Borough of North Plainfield has applied for a grant titled Emergency Management Performance Grant-EMPG/Emergency Management Agency Assistance (FY20-EMPG-EMAA-1814) in the amount of \$10,000.00;

WHEREAS, the Borough of North Plainfield has been granted a sub-award (CFDA#: 97.042) for the performance period of July 1, 2020 through June 30, 2021;

NOW, THEREFORE, BE IT RESOLVED, that the Borough of North Plainfield, in the county of Somerset, New Jersey, hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget of the year 2021; and

BE IT FURTHER RESOLVED, that the sub-grant, consisting of a total amount of up to \$10,000.00 Federal Award for the purpose of enhancing the Borough of North Plainfield's ability to prevent, protect against, respond to and recover from acts of terrorism, natural disasters and other catastrophic events and emergencies; and

BE IT FURTHER RESOLVED, that these funds will be used for Emergency Management purposes; and

BE IT FURTHER RESOLVED, that the Borough of North Plainfield does accept the Sub-award, and authorizes Brian L Martin, the Coordinator of the Office of Emergency Management to execute all documents related to this grant program.
