ORDINANCE NO. 23-05

CALENDAR YEAR 2023 ORDINANCE
TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS
AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Borough Council of the Borough of North Plainfield in the County of Somerset finds it advisable and necessary to increase its CY 2023 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Borough Council hereby determines that a 1.0 % increase in the budget for said year, amounting to \$234,373.87 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Borough Council of the Borough of North Plainfield, in the County of Somerset, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2023 budget year, the final appropriations of the Borough of North Plainfield shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$820,308.55, and that the CY 2023 municipal budget for the Borough of North Plainfield be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

AN ORDINANCE TO AMEND, REVISE AND SUPPLEMENT CHAPTER 22 OF THE BOROUGH CODE ENTITLED “LAND DEVELOPMENT”, MOST NOTABLY ARTICLE VIII ENTITLED “ZONING BOARD OF ADJUSTMENT,” AND MORE SPECIFICALLY BY AMENDING, SUPPLEMENTING AND REVISNG § 22-122-4, ENTITLED “DESIGNATION OF HISTORIC LANDMARKS AND HISTORIC DISTRICTS,” BY AMENDING, SUPPLEMENTING AND REVISING § 22-122.4.7 ENTITLED “NOTIFICATION TO NEW PROPERTY OWNERS.”

WHEREAS, pursuant to *N.J.S.A. 40:48-1* and *N.J.S.A. 40:48-2*, the governing body of a municipality may make, amend, repeal and enforce such ordinances, regulations, rules and by-laws not contrary to the laws of this State and/or of the United States, as it may deem necessary and proper for the good of government, order, and protection of person and property and for the preservation of the public health, safety and welfare of the municipality and its inhabitants and, as may be necessary to carry into effect the powers and duties conferred and imposed by this subtitle, or by any other law; and,

WHEREAS, pursuant to *N.J.S.A. 40:55D-65.1* of the Municipal Land Use Law, the governing body of a municipality may make and amend from time to time ordinances and regulations for the preservation of the historic character and historic structures of the municipality and as may be necessary to carry into effect the powers and duties conferred and imposed by the Municipal Land Use Law for the preservation of historic districts; and,

WHEREAS, the Borough of North Plainfield has an Ordinance in place for the regulation and preservation of its designated historic district, which requires that written notice of the requirements of the historic district be served upon buyers and sellers and their real estate brokers of properties within the historic district in order to acquaint them with the nature and extent of the Borough’s preservation efforts; and,

WHEREAS, the transmittal of the written notice of the requirements of the historic district to both parties of a real estate transaction and each broker can impose excessive paper waste and efforts to sellers and selling brokers, when the seller is selling a property in the historic district and need not be advised of such requirements; and,

WHEREAS, the Borough Council of the Borough of North Plainfield now intends to reduce paper waste and streamline closing practices for buyers and sellers of properties in the historic district.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Code of the Borough

of North Plainfield be amended, revised and supplemented as to Chapter 22 of the Borough Code, entitled "Land Development", most notably by amending, supplementing and revising Article VIII, entitled "Zoning Board Of Adjustment," and, more specifically, by amending, revising and supplementing § 22-122.4, entitled "Designation Of Historic Landmarks And Historic Districts," by amending, supplementing and revising § 22-122.4.7, entitled "Notification To New Property Owners," as follows:

§ 22-122.4.7, Notification to New Property Owners, is hereby amended as follows:

§ 22-122.4.7 Notification to New Property Owners.

Every municipal certificate of compliance issued to owners of properties or structures in the Historic District in connection with the sale or conveyance of properties or structures in the Historic District shall state, in conspicuous typeface, that the property or structure is subject to the limitations and regulations governing properties and structures in the Historic District under Article 22-122 of the Borough's Land Development Ordinance. Such notification, along with a copy of the appropriate ordinance and other pertinent HPC documents, shall be mailed by certified mail, return receipt requested, to the prospective buyer and ~~seller, realtor, and~~ attorney of the buyer. ~~[property, to the extent known]~~. This notice shall be sent in addition to the issuance of a regular certificate of compliance. Such notification shall be deemed actual and constructive notice to new property owners of the effect and applicability of these provisions to their ownership, use and improvement of their property.

NOW, THEREFORE, BE IT FURTHER ORDAINED that this Ordinance shall take effect, after final passage, twenty (20) days following action or inaction by the Mayor as provided by law or an override of a mayoral veto by the Council, whichever is applicable and publication in accordance with law, unless a resolution is adopted, pursuant to N.J.S.A. 40:69A-181(b), declaring an emergency and providing that this Ordinance shall take effect at an earlier date.

SIDEWALK REPLACEMENT – VARIOUS LOCATIONS PROJECT.**

WHEREAS, the Borough of North Plainfield (hereinafter referred to as the “Borough”) is in need of certain excavation, grading, concrete work and related services for the replacement of sidewalks at various locations in the Borough (hereinafter referred to as the “Project”); and,

WHEREAS, the Borough solicited bids for the Project and the following two (2) bids were received:

T. Fiotakis Construction, L.L.C.	\$ 87,555.00	\$35,500.00	\$123,055.00

WHEREAS, the estimate of Grotto Engineering Associates, L.L.C., the Borough’s Engineer on the Project, was One Hundred Fourteen Thousand Eight Hundred and Ninety Five Dollars (\$114,895.00) for the Project, indicating that the lowest bid was seven percent (7%) over the Engineer’s estimate, but that rebidding of the project was unlikely to produce any lower bids, and that, upon review, the low bid prices are reasonable; and,

WHEREAS, the Borough Engineer therefore recommended, in its review of bids and recommendation for award of contract dated March 6, 2023, a copy of which is on file in the office of the Acting Municipal Clerk of the Borough of North Plainfield, that the Borough award the contract to T. Fiotakis Construction, L.L.C. both as to the Base and Alternate Bid; and,

WHEREAS, Director of Law/Borough Attorney Eric M. Bernstein, Esquire and the offices of Eric M. Bernstein & Associates, L.L.C., as well as Grotto Engineering Associates, L.L.C., the Borough’s Engineer on the Project, have reviewed the bid submissions and recommend the award of the base bid and alternate bid contract for the Project to the lowest responsive and responsible bidder, T. Fiotakis Construction, L.L.C., whose main offices are located at 197 Central Avenue, Edison, New Jersey 08817 (hereinafter referred to as the “Contractor”) as there are no material defects with the bid proposal; and,

WHEREAS, the Borough of North Plainfield is desirous of obtaining the services of the Contractor to perform all those services contemplated in the Borough’s bid documents and the bid proposal submitted by the Contractor; and,

WHEREAS, the Borough of North Plainfield finds that the Contractor is the lowest responsive and responsible bidder for the Project, pursuant to the Local Public Contracts Law, *N.J.S.A. 40A:11-1 et seq.*

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough Council hereby awards the following Base Bid, Alternate Bid and Contract, subject to any and all approvals by other governmental agencies for the work:

CID Monthly Report

A Sample of Investigations & Arrests

On January 4, 2023, a resident of Grove Street came to headquarters and reported that last November someone accessed her online bank account with her username and password. The suspect then attempted to deposit a \$7,500.56 check utilizing the mobile application. The victim notified the bank regarding this check being deposited and that someone had accessed the account. In December, another check was deposited in the amount of \$12,000.21. The victim notified the bank again about this fraudulent check deposit and bank security then closed her account on December 30, 2022 temporarily until they conclude their investigation.

NORTH PLAINFIELD POLICE JANUARY 2023 MONTHLY REPORT

On January 7, 2023, while on patrol, a North Plainfield officer observed a Watchung patrol unit pull up to a white SUV which had run off the road and was now disabled in the wooded area just east of North Drive and Route 22 East. The Watchung officer advised the North Plainfield officer that the vehicle was recently pursued by the Warren Police and was involved in an attempted home burglary in Warren Township. North Plainfield officers assisted Watchung in searching the woods for the actors. Watchung officers located an actor attempting to hide in the stream in that area. The male actor was placed under arrest by Watchung, handcuffed, and turned over to the Warren Police. North Plainfield officers continued to assist Watchung in the search. Additional agencies involved in the search included the NJ State Police helicopter, Warren, Greenbrook, and the Somerset County Sheriff's Office. An additional female actor was located and placed under arrest in the area of Mali Drive and Meadowbrook Drive by the K-9 officer.

On January 23, 2023 at 2125 hrs., patrol responded to Somerset Street on the report of a stolen motor vehicle. The reporting party, a resident of Plainfield, reported he left his vehicle, a 2013 Black Cadillac ATS, unlocked and running while he and some friends went into the business. When they came out the vehicle was stolen. The victim further advised that he left \$3,000 in cash in the back seat, which was his payment from work. Surveillance video showed an unknown male suspect wearing a black jacket and grey sweatpants enter the vehicle. The vehicle was entered into NCIC as stolen and a county alarm was issued. At 2327 hrs., the Plainfield Police notified this agency that the vehicle was located after it crashed on Central Avenue during a pursuit with the Plainfield Police. The suspect fled on foot and escaped.
