AN ORDINANCE AMENDING, REVISING AND SUPPLEMENTING CERTAIN SECTIONS OF THE NORTH PLAINFIELD BOROUGH CODE BY REMOVING SECTIONS OF THE NORTH PLAINFIELD BOROUGH CODE AS TO CHAPTER IV, GENERAL LICENSING MOST NOTABLY DELETING SECTION 4-15, ENTITLED "MASSAGE, BODYWORK AND SOMATIC THERAPY"

WHEREAS, the Borough of North Plainfield wishes to amend the provisions of the current Borough Code of the Borough of North Plainfield.

NOW, THEREFORE, BE IT ORDAINED by the Borough of North Plainfield, County of Somerset, State of New Jersey that the Borough amends, revises and supplements the Borough Code of the Borough of North Plainfield by deleting Chapter IV, General Licensing, Sections 4-15.1 through 4-15.11, "Massage, Bodywork and Somatic Therapy."

NOW THEREFORE, BE IT FURTHER ORDAINED THAT:

- 1. Proper signage shall be erected after receipt of any approvals required pursuant to state or county regulations and requirements.
- 2. Any ordinance or portions of ordinances that are inconsistent with this Ordinance shall be updated as to their inconsistencies only.
- 3. If any provision or paragraph of this Ordinance shall be held invalid by any court of competent jurisdiction, the same shall not affect the other provisions or paragraphs of this Ordinance, except so far as the provisions or paragraphs so declared invalid shall be separable from the remainder or any portion thereof.

4. This C	Ordinance shall take e	effect after final passage, twenty (20) days	following
action or inaction by the Mayor as provided by law or an override of a mayoral veto by the			
Council, whichever is applicable, and publication in accordance with law, unless a resolution is			
adopted, pursuant to N.J.S.A. 40A:69A-181(b), declaring an emergency and providing that this			
Ordinance shall take effect at an earlier date.
