The contract will allow eighty (80) calendar days for completion of the work from the notice to proceed. Notice to proceed will be issued on or about August 15, 2013. Payment for Contract Documents shall be by cash, money order, or certified check only and shall be made payable to the SUBURBAN CONSULTING ENGINEERS, INC. Contract documents cannot be purchased through the mail. SUBURBAN CONSULTING ENGINEERS, INC. will not be held responsible for contract documents purchased via courier service.

A pre-bid meeting will be held on Tuesday, July 16, 2013 at 11 A.M, at the Municipal Building. It is strongly recommended that all interested bidders attend.

Proposals shall be made on the forms provided and made part of the Contract Documents, which shall be submitted intact. A certified check or cashier's check made payable to the order of the Borough of North Plainfield, or a duly executed Bid Bond, in the amount of ten (10) percent (%) of each bid, but in no case in excess of \$20,000.00 must be deposited by the Bidder together with a Surety Consent evidencing that he can obtain the required Performance Bond.

The successful Bidder shall be required to comply with requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27, and deliver to the Borough an executed Performance Bond of a responsible indemnity company authorized to do business in the State of New Jersey.
