No Proposals will be accepted after said hour. The contract scope shall include demolition of two (2) existing structures, construction of asphalt pad, full pavement restoration of parking area, and construction of a 40° +/- diameter timber salt dome structure on 10° reinforced concrete wall, new generator, and surveillance improvements. Additional improvements include electrical, conveyor system and mechanical ventilation system for the salt dome structure. The contract will allow ninety (90) calendar days for completion of the work from the notice to proceed. Proposals shall be made on the forms provided and made part of the Contract Documents, which shall be submitted intact. A certified check or cashier's check made payable to the order of the Borough of North Plainfield, or a duly executed Bid Bond, in the amount of ten (10) percent (%) of each bid, but in no case in excess of \$20,000.00 must be deposited by the Bidder together with a Surety Consent evidencing that he can obtain the required Performance Bond.

The successful Bidder shall be required to comply with requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27, and deliver to the Borough an executed Performance Bond of a responsible indemnity company authorized to do business in the State of New Jersey.
