- Weatherization program, better known as WAP is a program that allows us to
 - □ Insulate attics.
 - □ Perimeter insulation in the basement.
 - □ Exterior wall insulation.
 - □ Replace hot water heater.
 - □ Wrap hot water tank.
 - □ Wrap water line at water tank.
 - Replace showerhead with a low flow.
 - □ Replace faucet aerator with a low flow.
 - ☐ Install carbon monoxide detectors
 - □ Compact fluorescent light bulbs
 - ☐ We also do numerous base-load measures
 - □ Replacement of oil, gas or electric heating systems.
 - □ Repair or replace heating distribution system.
 - ☐ Install chimney liners if heating system is replaced.
 - □ Replace high-energy burden refrigerators.
- ❖ All heating system work is free to qualified home owner.
- ❖ All landlords are required to contribute 50% of any heater work.

What is Weatherization Assistance Program?

Weatherization Assistance Program (WAP) is the nation's core program for the delivering energy efficiency services to low-income household. The program goal is to reduce energy costs to low – income families by improving the energy efficiency of their homes while ensuring their health and safety. Nationwide, weatherization benefits low-income households and communities by generating an average energy cost savings of \$ 418 per home each year.

Professionally trained weatherization crews perform on-site home energy audits utilizing state of the art equipment to identify outside drafts and inspect heating systems for efficiency safety. Weatherization crews install insulation, seal off air leaks, make modifications to existing heating systems, and make minor repairs to ensure safety. This energy savings measures help to reduce heating costs for years to come.

Do I qualify for services?

Do I have to own my own home to qualify for services?

You don't have to own your own home to qualify. You may qualify whether you own or rent, live in a single-family home, multifamily housing complex or in a mobile home.

Do I have to be a certain age or meet an income guideline to qualify?

If you receive Supplemental Security Income (SSI) and/or Aid to families with Dependent Children (AFDC), you are automatically eligible. While preference is given to persons over 60, persons with disabilities and in some cases, children, you may also be eligible for assistance if your income meets the following federally established income guidelines:
